## RE: California Proposition 65 Compliance Requirements

Dear Valued Customer,

California Proposition 65, the Safe Drinking Water and Toxic Enforcement Act of 1986 administers extremely stringent requirements for certain substances that are found in products being sold in to the state of California. In many instances, these intensive standards are far below the levels which the FDA itself would consider harmful for human consumption.

Dynalab Labware would like to assure you that we periodically survey our supply chain as it relates to compliance of Prop 65. **We have previously completed distributor required "Prop 65" files with information that may be changed below. Please review and update accordingly.**
